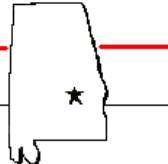

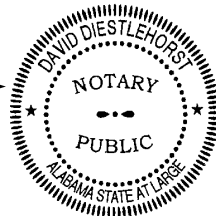
A. REGULAR EXPIRATION STAMP
 Same imprint as the self-inking stamp except this stamp is made with high quality wood base and handle and requires a separate pad.

 MY COMMISSION EXPIRES: MAR. 10, 2007

B. SELF-INKING EXPIRATION STAMP
 This is a rectangular black plastic cased stamp that contains its own ink supply and has your expiration date.



C. "SEAL"-METAL IMPRESSION
 This is the highest quality metal hand-held embossing seal on the market. It leaves a raised impression on the paper. A Leatherette carrying case is included.



D. IMPRESSION INKER
 This inker quickly marks the raised portion of the impression with black ink. Shading with a pencil is also effective but very time consuming.

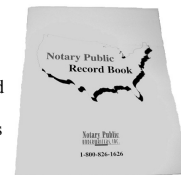


E. JURAT STAMP
