**A. REGULAR EXPIRATION STAMP**  
 Same imprint as the self-inking stamp except this stamp is made with high quality wood base and handle and requires a separate pad.

**B. SELF-INKING EXPIRATION STAMP**  
 This is a rectangular black plastic cased stamp that contains its own ink supply and has your expiration date.



**C. "SEAL"-METAL IMPRESSION**  
 This is the highest quality metal hand-held embossing seal on the market. It leaves a raised impression on the paper. A leatherette carrying case is included.



**D. IMPRESSION INKER**  
 This inker quickly marks the raised portion of the impression with black ink. Shading with a pencil is also effective but very time consuming.

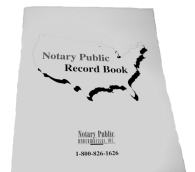

- **Sign** your name as you wish to sign as a notary.
- Please have three witnesses complete the bottom section as your references. This must be signed in their own handwriting and they must be residents of your county. Please have them fill in their residential address.
